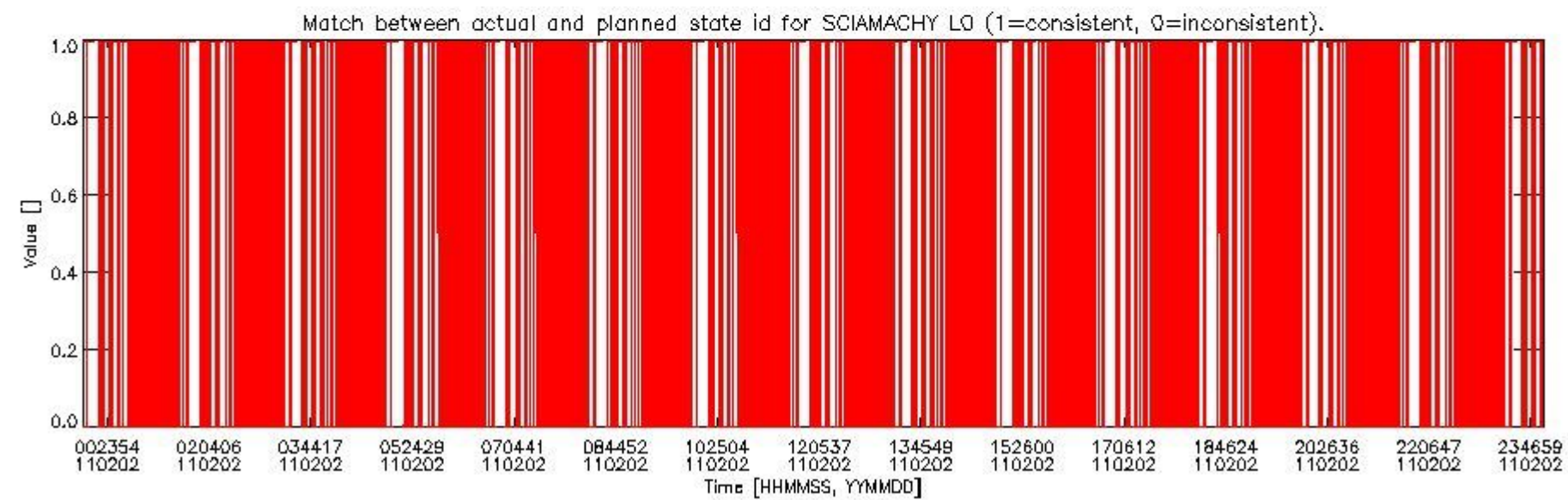
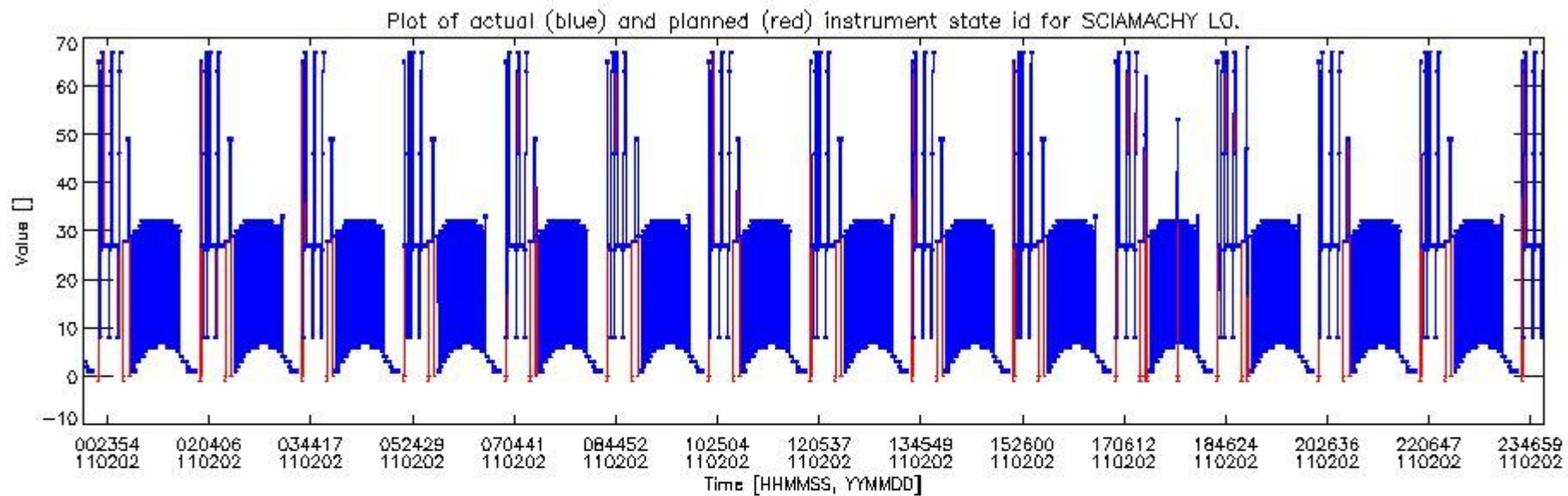


0.3 State monitoring

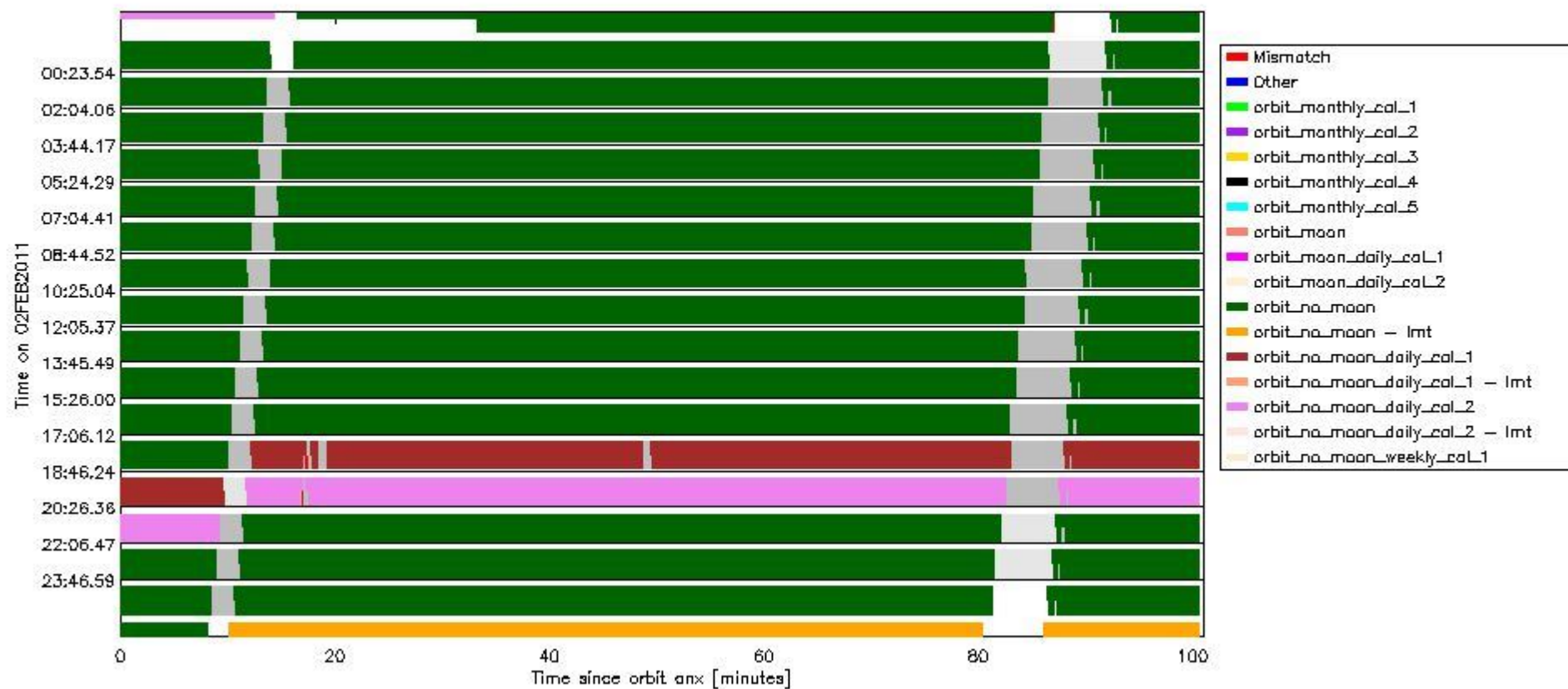

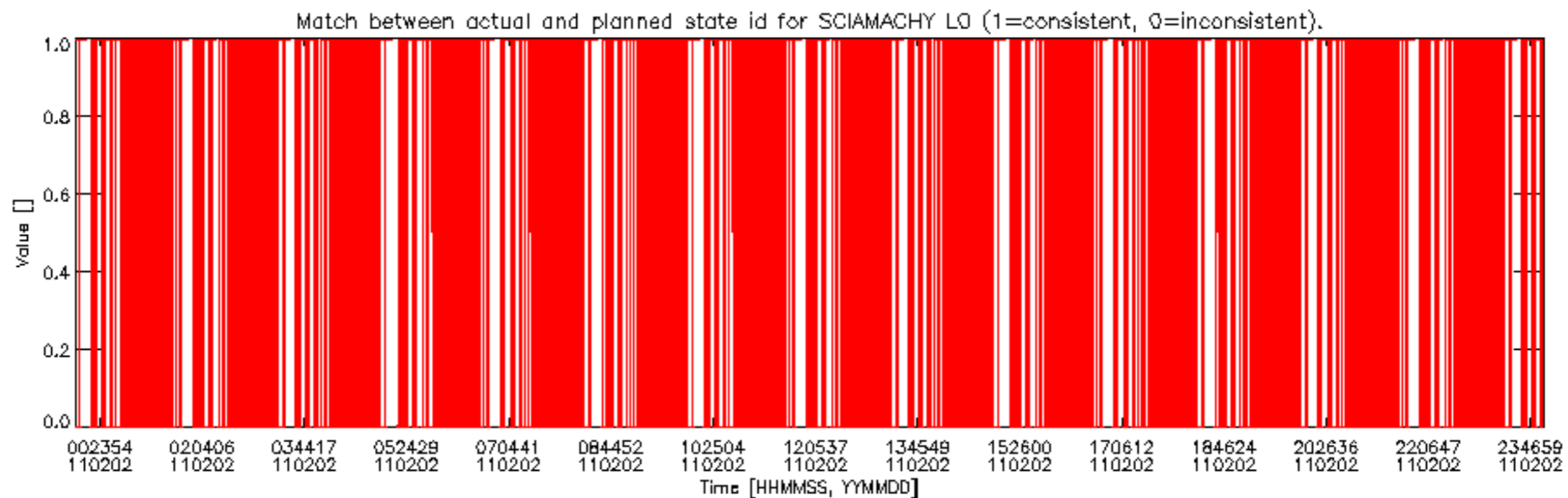
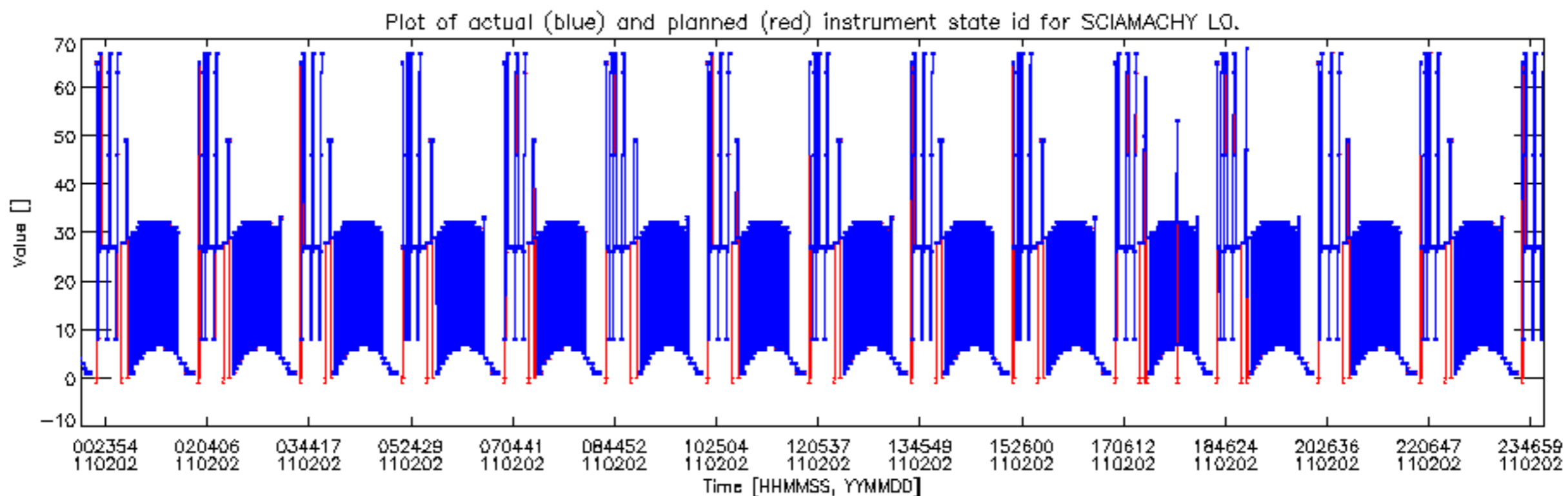












Bar plot of planned DMOP activities and new calibration data for SCIAMACHY.
