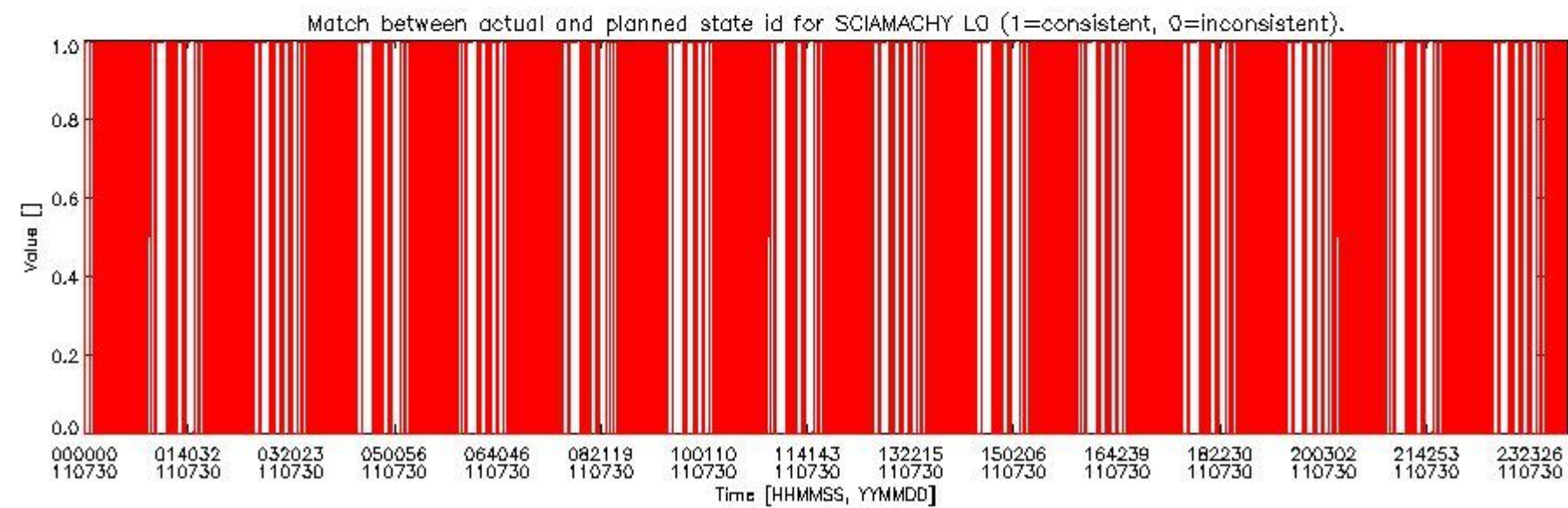
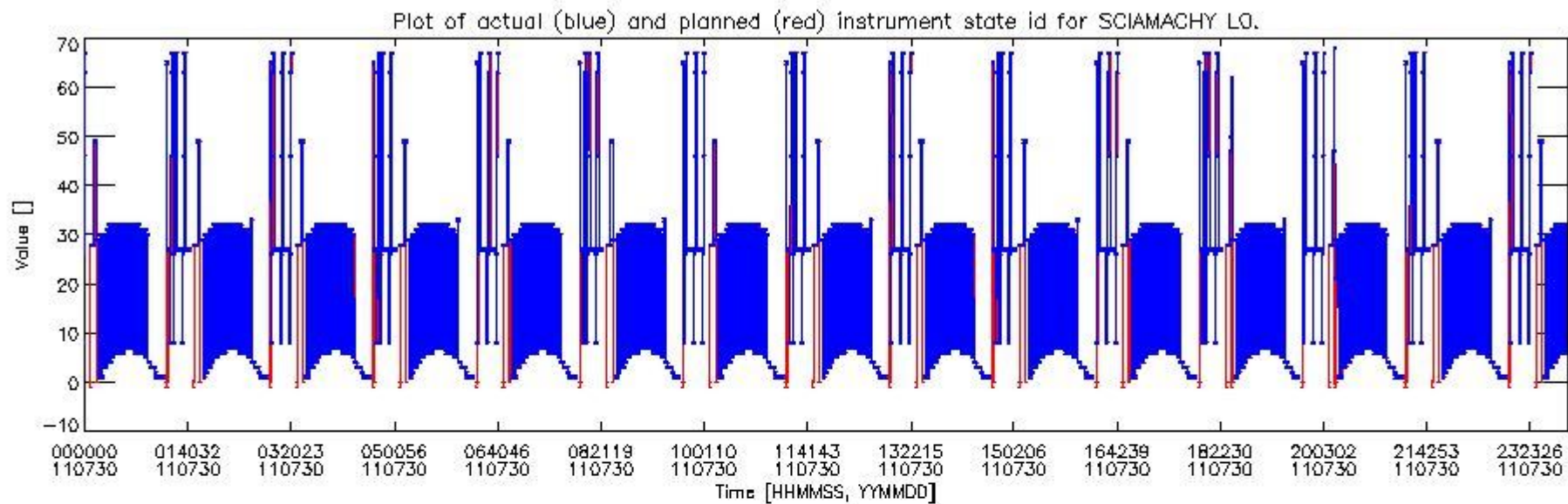


### 0.3 State monitoring

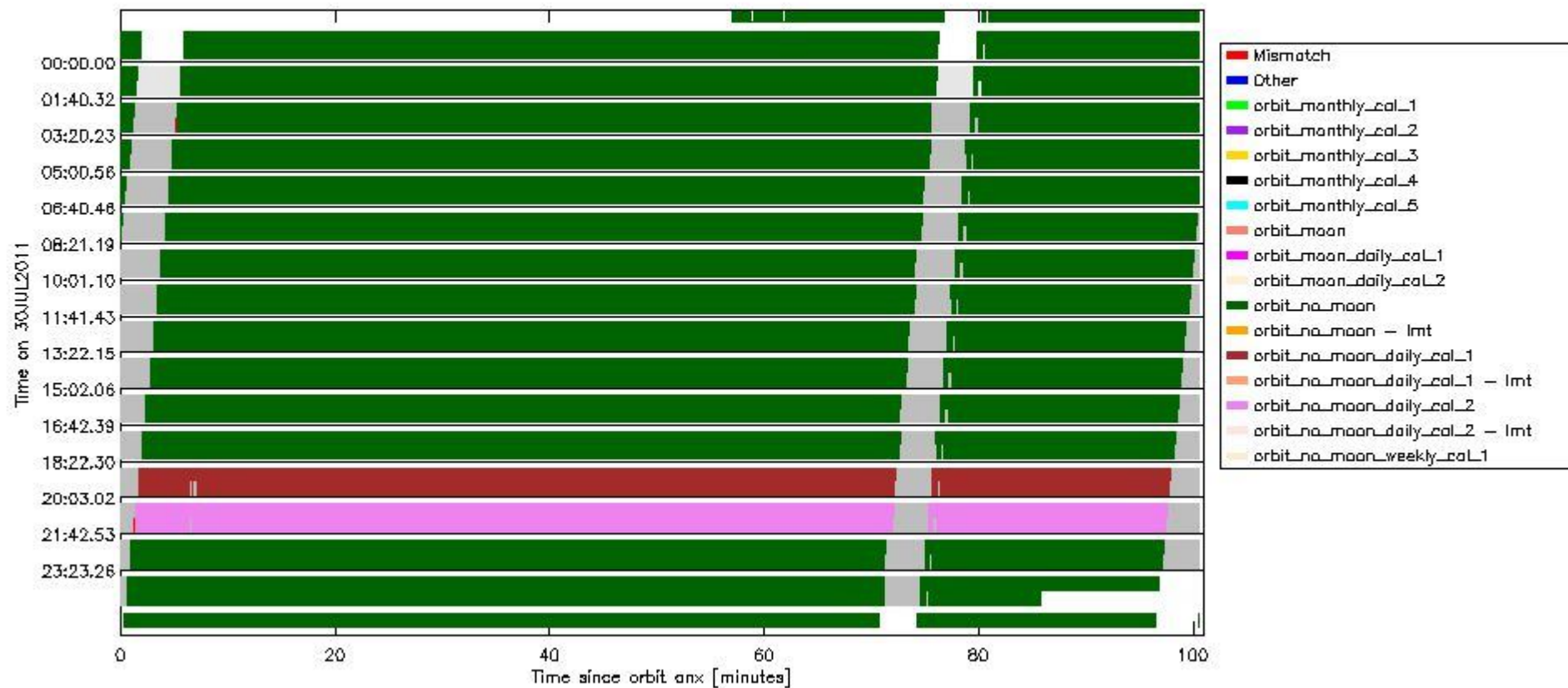

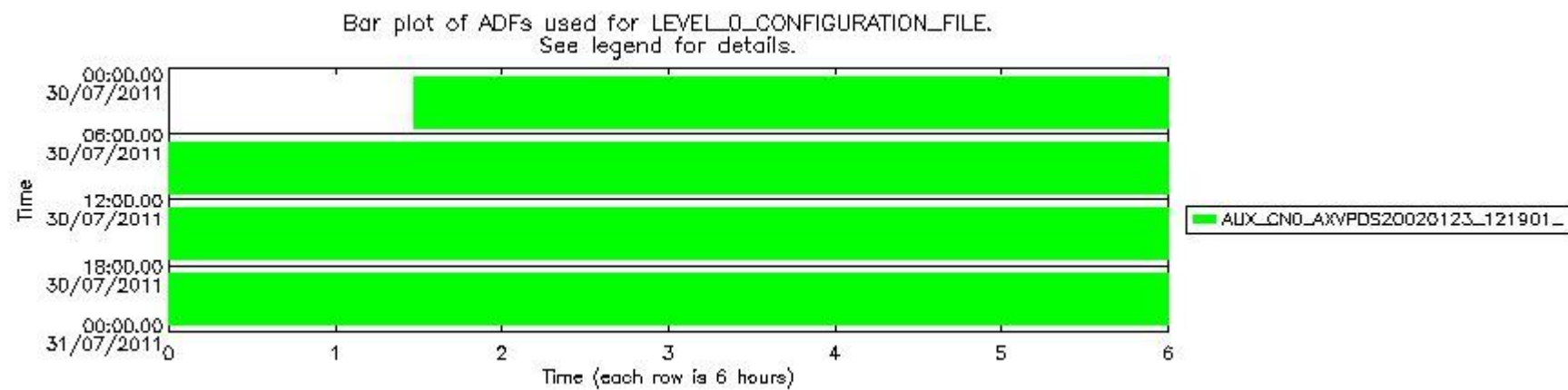
## 0.4 ADF monitoring

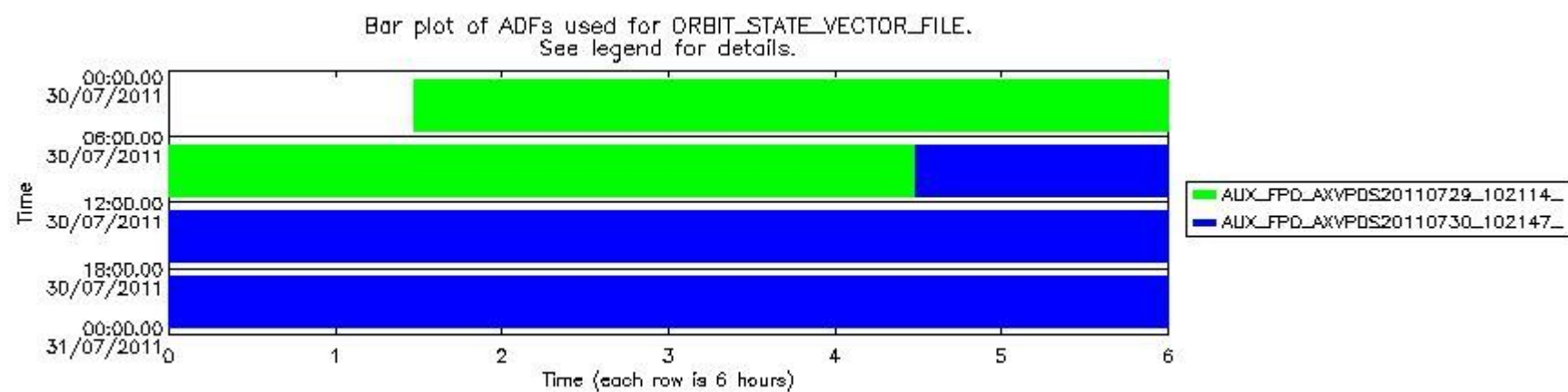

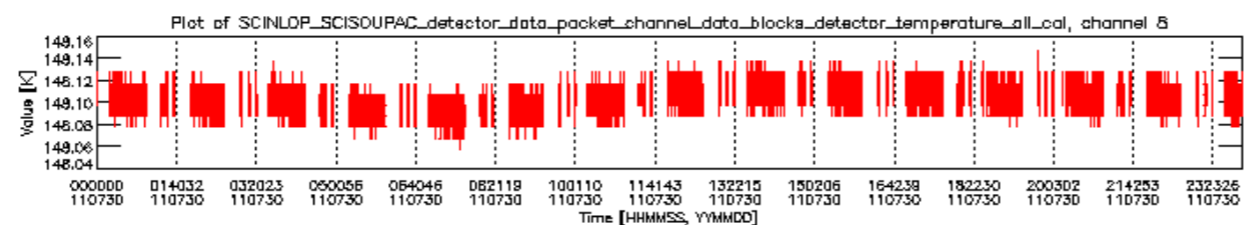
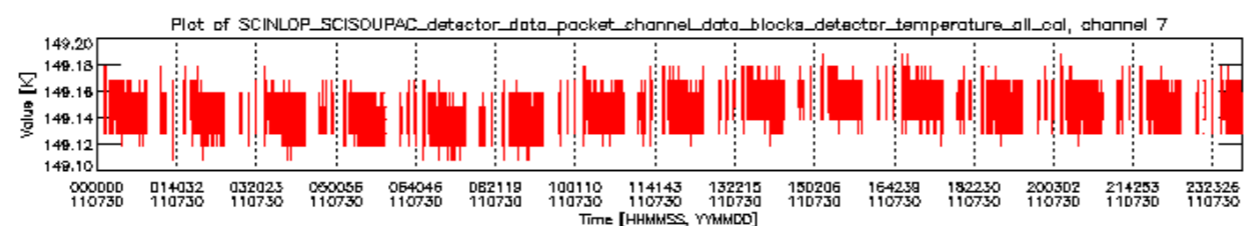
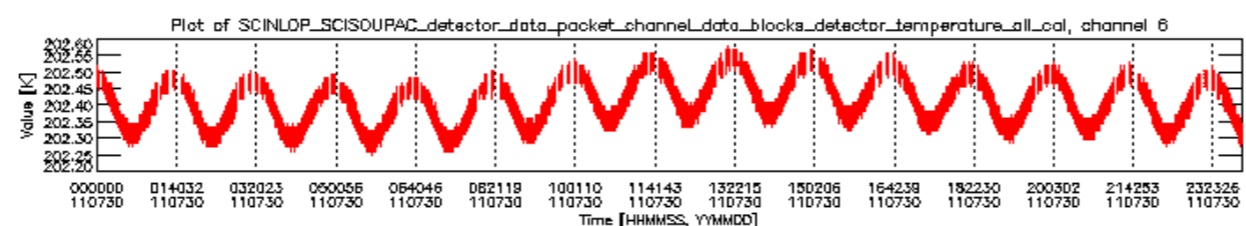
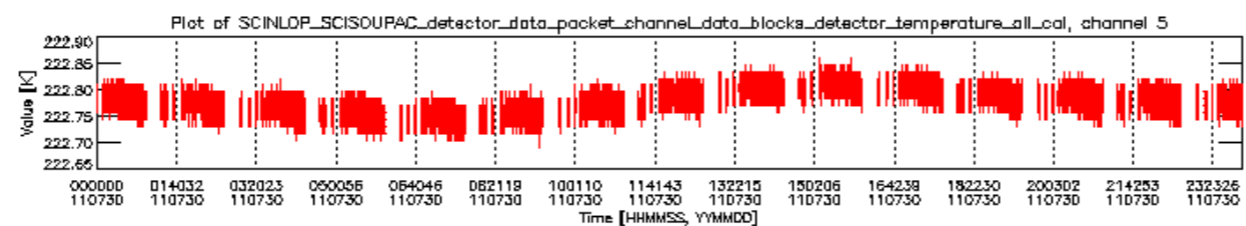
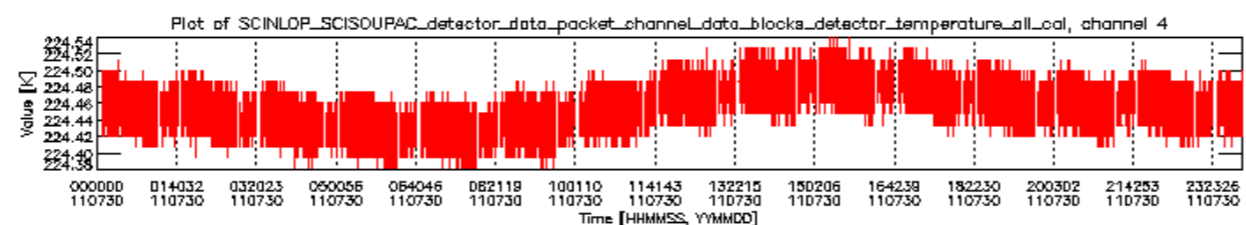
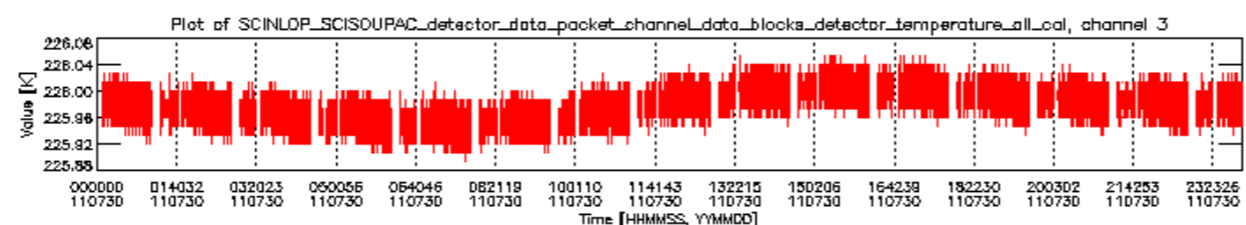
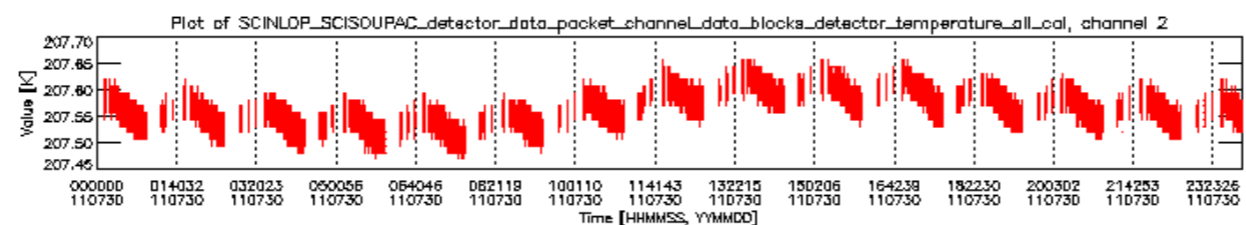
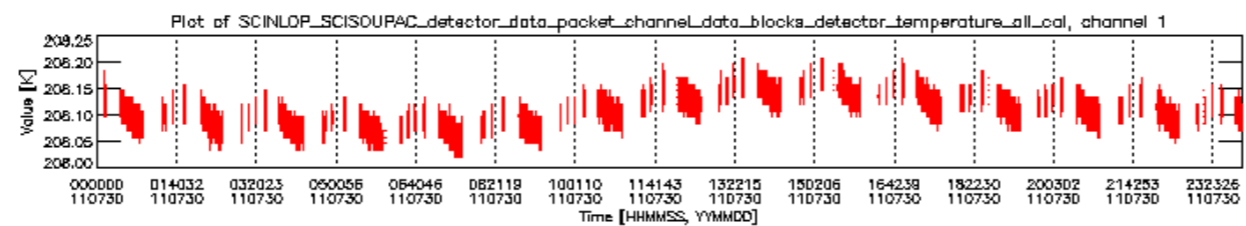


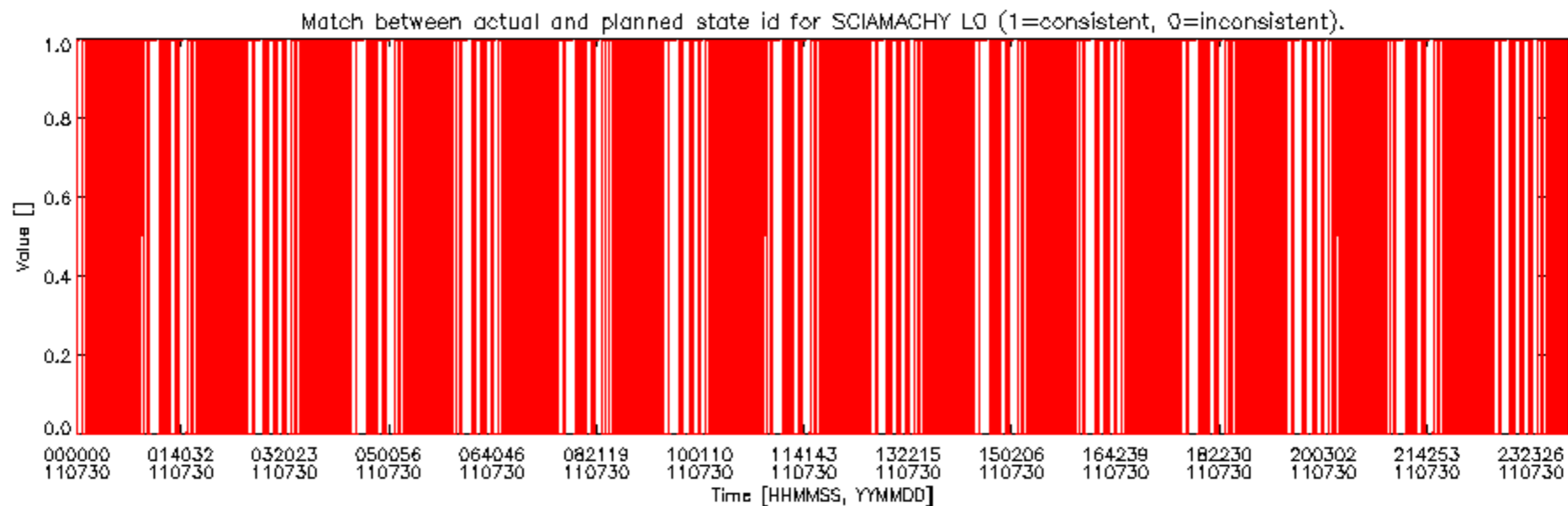
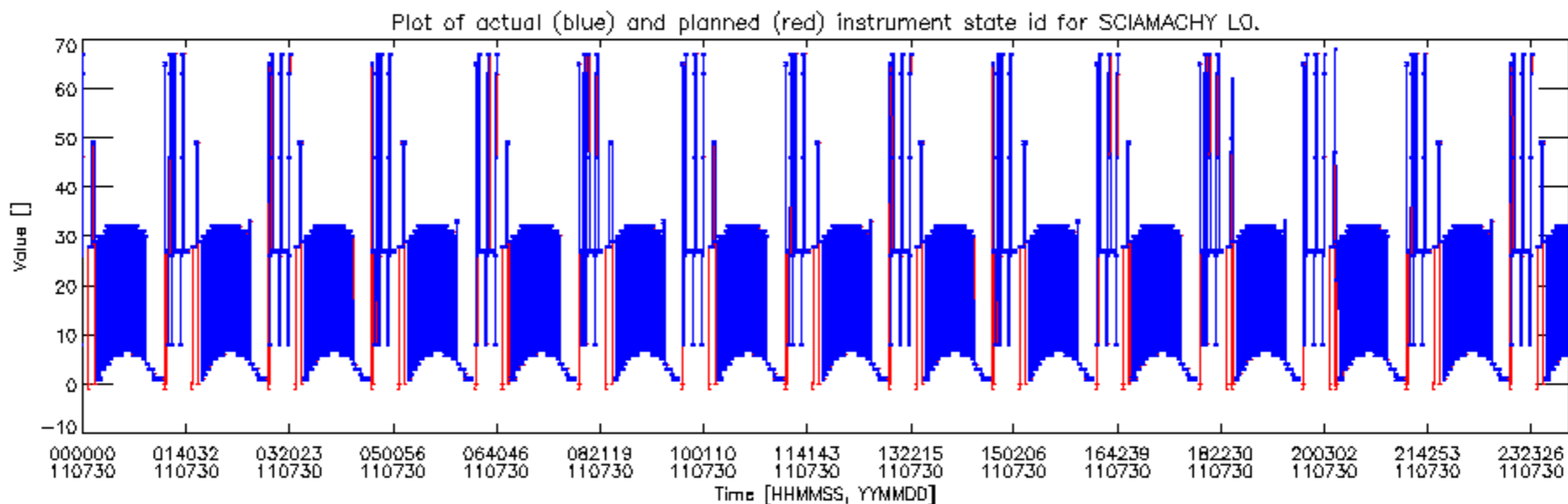












Bar plot of planned DMOP activities and new calibration data for SCIAMACHY.
